SURFACE PREPARATION

Remove the dust or stain on the application surface. The ambient and surface temperature must be between 5-30°C during the application.

APPLICATION

It can be applied on easily both newly painted surfaces and old painted surfaces as a paint primer. Spread homogenously on surfaces and enables strong binding of the new paint to the application surface.

In airless applications, after 30% thinning, application can be made between 150-200 bars with the recommended nozzle.
