SURFACE PREPARATION

Surfaces should be cleaned out from dust and dirt.

APPLICATION

As a paint primer, Natura Polizolan (Primer) can be applied on new or prepreviously painted surfaces. When it is applied on surfaces, new paint will adhere strongly on the surfaces. Polizolan should not be applied on the paints that have high surface tension like matt and semi matt synthetic paints (such as Matrix Mat and Matrix Yarı Mat). İf applied, micro cracks may form on the surfaces in the course of time.

Thinning Ratio	When used as paint primer; for exteriors, 1 Lof Natura Polizolan (Primer) should be thinned with 5 L water, and for interiors, 1 L of Polizolan should be thinned with 7 Lof water. IT SHOULD NOT BE
